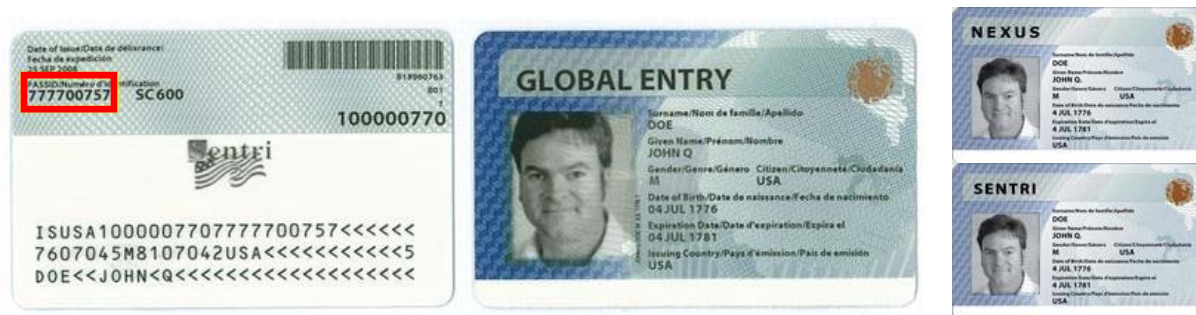


How to Use a CBP Trusted Traveler PASS ID to Access TSA Pre✓™

U.S. citizens who have been approved for a U.S. Customs and Border Protection (CBP) Trusted Traveler program (Global Entry, NEXUS, SENTRI) may be eligible for expedited security screening with TSA Pre✓™. CBP Trusted Traveler members hold a unique PASS ID that is located on the back of their membership card. In order to participate in TSA Pre✓™ you must be a U.S. citizen flying domestically on a participating airline, including Alaska Airlines, American Airlines, Delta Air Lines, United Airlines or US Airways.

Members interested in participating in TSA Pre✓™ should enter their PASS ID into the ‘Known Traveler’ field when 1) booking a flight reservation 2) saving their PASS ID in their Alaska, American, Delta, United, or US profile or 3) booking through a third party.

Qualifying for TSA Pre✓™ using a PASS ID

CBP Trusted Traveler members can utilize their PASS ID to become eligible for TSA Pre✓™ by:

1. Making a flight reservation:

- Passengers must enter their PASS ID into the ‘Known Traveler’ field when making a reservation with participating airlines to be eligible for TSA Pre✓™.

2. Updating their profiles:

- Passengers may be eligible for TSA Pre✓™ on all future reservations by updating their airline profiles with their PASS ID on:
 - Alaska Airlines:
 - Sign in to their Alaska Airlines profile on www.alaskaair.com, click **My Account**, select **Settings & Preferences**, under **International Travel Information** click the link for **Edit my Information**, enter a valid **PASS ID** into the ‘**Known Traveler**’ field, and click **Save**
 - American Airlines:
 - Sign in to their AAdvantage profile on www.aa.com, access the **Personal Information and Password** tab, select **Edit** next to **Customs and Boarding Protection ID**, enter a valid **PASS ID**, and click **Submit**

- Delta Air Lines:
 - Sign in to their SkyMiles account, select **Save Your Secure Flight Passenger Data** under **Manage My Account**, update their **Secure Flight Passenger Data** by entering a valid **PASS ID** into the ‘**Known Traveler**’ field and click **UPDATE**

- United Airlines:
 - Sign in to their MileagePlus profile on www.united.com, click **My Account**, click **Manage Profile**, under **Account Information** click **TSA Pre-Screening Program**, click the dropdown next to the “**I have a Known Traveler Number/PASS ID**” field, enter a valid **PASS ID**, check the box for “**I would like to participate in the TSA pre-screening program,**” click **Save**

- US Airways:
 - Sign in to their Dividend Miles account on www.usairways.com, under **Dividend Miles** click **My account**, click **Account Information**, scroll down to the bottom of the page then enter a valid **PASS ID** into the **Known Traveler #** field, click **Save Changes**

3) Using a third party booking agent:

- Online:
 - Since every site is unique, be sure to enter a valid PASS ID into the ‘Known Traveler’ field before finalizing your reservation.

- Making a phone call:
 - Tell the travel agent to enter your PASS ID into the ‘Known Traveler’ field when making a flight reservation
